# **RULES AND REGULATIONS:**

# **1. AICF RULE FOR RATING RESTRICTION TOURNAMENTS**

 Players who finished first or second in any rating restricted tournament will not be eligible to play in any rating restricted tournament for one year from the date of such achievement"

 The earlier rule of threshold of 36 months remains the same (once the player crosses the rating threshold he cannot participate for the event below that rating level for next 36 months).

## 2. SYSTEM OF PLAY

The Latest FIDE Rules in force shall apply and the Swiss system will be followed.

#### 3. MODE OF TOURNAMENT

Total nine rounds shall be played.

#### 4. TIME CONTROL

60 minutes + 30 seconds increment per move from move no.1

#### 5. TIE BREAK

Buchholz tie-break system will be applied. In case of tie, prizes will not be shared.

#### 6. DEFAULT TIME

**15 Minutes** 

#### 7. AICF PLAYER REGISTRATION

AICF player registration is compulsory for all Indian players. AICF Player Registration fee is Rs. 300/- for the year 2025-2026. As per latest AICF regulation dated 31.07.2017, it is informed that from 01 September, 2017 all AICF registrations will be accepted only through online. Players / Arbiters registration should be done well before the start of event (Tournament). New entrants to the field of chess are informed that AICF players registration is mandatory and it should be done well before participating in any tournament. For renewing AICF registration of existing players, please click http://aicf.in/players/-For fresh AICF registration please click http://aicf.in/online- player-registration/ For fresh AICF registration, players are requested to keep their scanned passport size photograph and birth certificate and a valid email address (unique) not used by any other person/ player for AICF, ready before the registration process.

Note : Only passport size (less than IMB) photographs in jpeg format should be uploaded.

#### 7. MADURAI DISTRICT PLAYER REGISTRATION

Madurai DCC Registration fee is Rs.75/- for the year 2025 – 2026 (for Madurai district players only)

#### 8. PROTESTS

Protests if any, against the decision of the Chief Arbiter shall be made in writing with protest fee of Rs.1000/- within 15 minutes of the occurrence of the incident to the appeals committee. The protest fee will be refunded if the appeal is upheld.

#### 9. TNSCA PLAYER REGISTRATION

TNSCA player registration is compulsory for all Tamil Nadu players. TNSCA Player Registration fee is Rs.150/- for the year 2025-2026. Players / Arbiters registration should be done well before the start of event (Tournament). New entrants to the field of chess are informed that TNSCA players registration is mandatory and it should be done well before participating in any tournament. For renewing TNSCA player registration of existing players, please click https://registration.tamilchess.com/. For fresh TNSCA registration please click https://registration.tamilchess.com/new-register/ For fresh TNSCA registration, players are requested to keep their scanned passport size photograph and birth certificate and a valid email address ready before the registration process.

Note : Only passport size (less than 1 MB) photographs in jpeg format should be uploaded...

#### **10. APPEALS COMMITTEE**

Before the commencement of the Tournament, appeals committee will be formed from the senior participants present at the players meeting. The appeals committee decisions will be final and binding on all players concerned.

#### **11. WITHDRAWALS**

A player may withdraw at any stage of the event, after informing the chief arbiter in writing

#### 12. RIGHTS OF ADMISSION

The AICF/TNSCA/MDCC / organizer Global Sports Foundation reserve the rights of admission to the venue.

#### **13. WRIST WATCHES**

AICF has banned the wrist watches while playing in FIDE Rated events. Players are instructed not to wear any kind of wrist watches while playing.

## **14. INTERPRETATION**

For further interpretations of the rule(s), and deciding any aspect not covered by the said tournament prospectus, the decision of the Tournament Director shall be final and binding on all the participants. The Tournament Director has every right to make any addition/deletion/amendment to these rules. However, such changes shall be displayed on the notice board with the prior approval from AICF & TNSCA.
